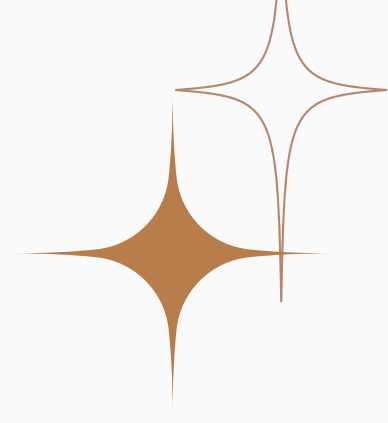

# HOW IT WORKS...



## 1 COMPLETE THE BOOKING FORM

Once you've read through this bridal booklet please head over to my website and fill out the online booking form, this will allow me to put together your quote for you.

## 2 TIME FOR YOUR QUOTE

Alongside your bespoke quote you will also receive my T&Cs with details on how to pay your deposit.

## 3 PAY YOUR DEPOSIT

Your date is confirmed once I have received your deposit. Unfortunately I cannot reserve dates without receiving a deposit. Payment details will be sent alongside your quote, and can also be found in this booklet.

## 4 CONFIRMATION

You are all booked. Thank you for choosing me to be your MUA! We will discuss the next steps via email. Your trial will be booked in for a date 2-3 months before your wedding day.

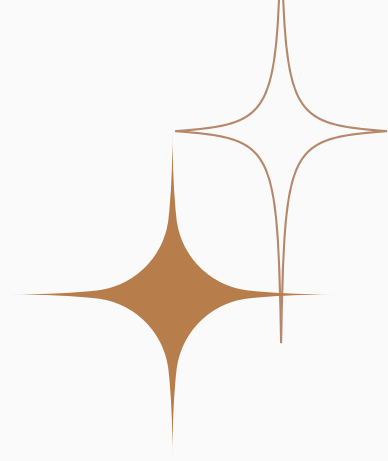

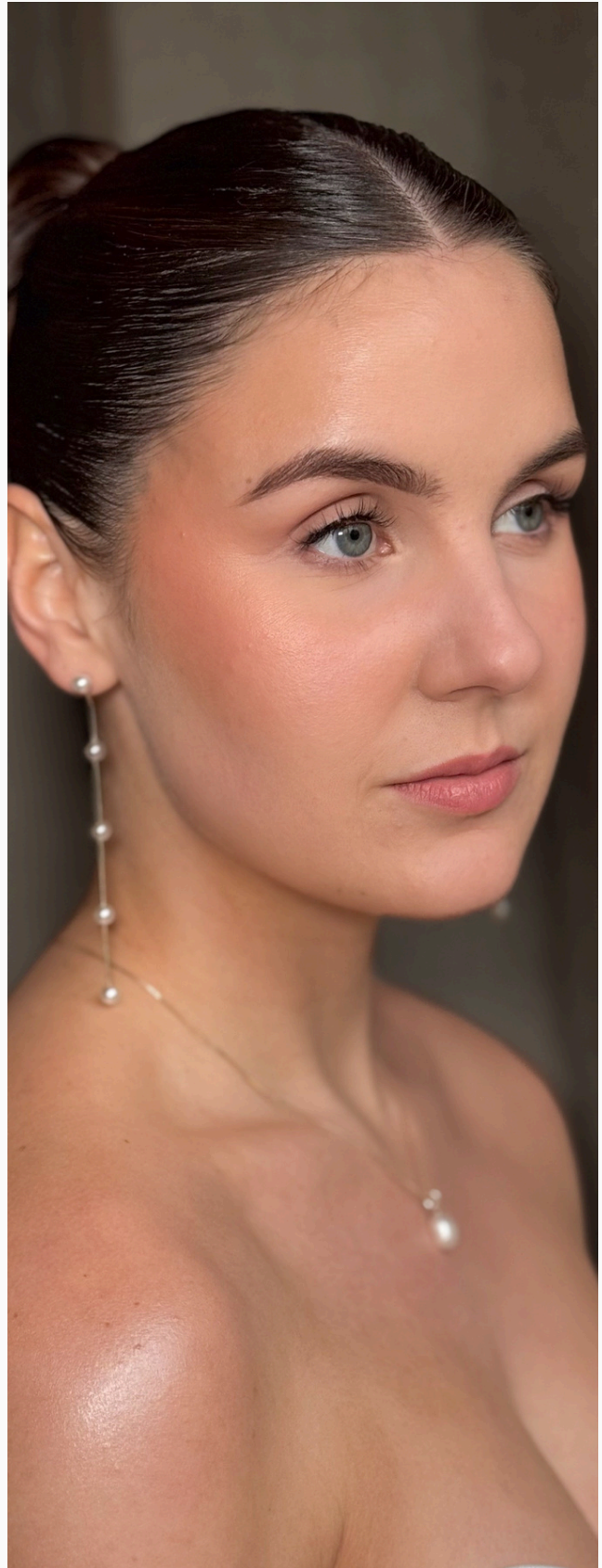

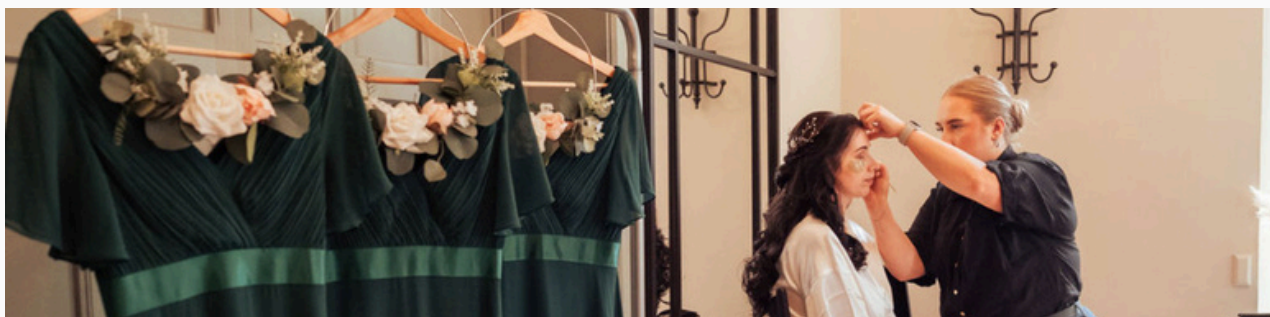

<p><b>ADULT BRIDAL PARTY MEMBERS</b></p>	<p>This is for Bridesmaids, MOB/MOG or any guests. Complimentary false lashes are included.</p>	<p><b>£70/80</b> PER PERSON</p>
<p><b>JUNIOR BRIDAL PARTY MEMBERS</b>  12 &amp; UNDER</p>	<p>For bridesmaids or guests aged 12 and under. This service includes shimmer eyeshadow, blush, and gloss, applied with the guidance of a parent or guardian.</p> <p>If they would like additional steps beyond what is listed above please book them as an adult bridal party member.</p>	<p><b>£30</b> PER PERSON</p>
<p><b>STAY-ON SERVICE</b></p>	<p>I will be by your side for touch ups during your photos, making sure you look good from every angle!</p>	<p><b>£55</b> PER HOUR</p>
<p><b>CHANGE OF LOOK</b>  BRIDE ONLY</p>	<p>Having a second look (dress/hair/makeup) for your evening reception is becoming more and more popular. I will return to your venue about 45 minutes before your guests arrive to enhance your current style and transform it into a fresh, glamorous look—perfect for dancing the night away!</p>	<p><b>£95</b></p>
<p><b>LUXURY TOP-UP KIT</b></p>	<p>Includes mini Charlotte Tilbury pressed powder, setting spray, and your chosen lipstick.</p>	<p><b>£90/£100</b></p>



# EXTRA FEES

2027/2028

<b>ADDITIONAL ARTIST</b>	For larger Bridal Parties. Due to various factors (i.e. venue access time/ceremony time) I may not be able to complete everyone myself. I will source and liaise with the MUA up until your wedding day.	£85
<b>SPLIT LOCATION</b>	Sometimes due to the nature of a wedding morning and time restrictions I may need to do makeup on a couple of Bridal Party members elsewhere before moving to the venue.  This charge includes mileage (up to 10 miles) between two venues.	£30/£35
<b>UNSOCIABLE HOURS</b> LEAVING HOME BEFORE 6AM	This fee will be calculated once I have completed your schedule (around 1 month before your wedding day) and added to the final total.	£20 PER HOUR
<b>SUNDAYS &amp; BANK HOLIDAYS</b>	An additional fee applies for services scheduled outside of regular business hours or on bank holidays.	£50
<b>SATURDAY TRIAL</b>	Your trial will be scheduled on a weekday. If a Saturday works better, this may be available during the off-peak season.	£40
<b>MILEAGE</b>	This fee is for travel to and from your venue and will be estimated at the time of booking. 10 miles are included in the price.	60P PER MILE

# WEDDING MORNING TIMELINE...

Below is an **example** of what your wedding morning might look like.

ARRIVAL	SET UP KIT 15 MINS
BRIDESMAID 1 60 MINS	BRIDESMAID 2 60 MINS
BRIDE 90 MINS	BRIDESMAID 3 60 MINS
TOUCH UPS	GET IN DRESSES (AROUND 1 HR BEFORE CEREMONY)
ANY FINAL TOUCH UPS & PHOTOS	BRIDE LEAVES FOR REGISTRAR MEETING (10-15 MINS BEFORE)
PACK UP & LEAVE	

Timelines will always be different depending on the size of the party, access time, and ceremony time. I require a minimum of 60 mins with the bride, if not 90 minutes.



# DEPOSITS & PAYMENTS

To secure your booking a *non-refundable and non-transferable* deposit of **£50 is required**. Please note I cannot hold your date without receiving the deposit. Dates tend to fill up quickly so to avoid disappointment it's recommended to send your deposit as soon as possible.

On the day of your trial 50% of the remaining balance will be due. I will confirm the exact amount with you when we schedule your trial.

The final balance is due 14 days before your wedding. Don't worry about remembering all of this, I will be sure to send out reminders when the due date is approaching!

Please only make payments on the date given. I cannot accept early payments.

Payments are to be made via bank transfer only (details below).

# WHAT YOU GET FROM ME...

## **10+ YEARS EXPERIENCE**

With so many weddings under my belt you can be assured you are in safe hands. I know how to create the perfect makeup look tailored to each person. Additionally with the experience I have I pride myself on being the calming presence a bride needs on her wedding morning.

## **LUXURY & PREMIUM PRODUCTS**

I am very proud of the kit I have built over the years. I use brands such as Charlotte Tilbury, Nars, Estée Lauder, Hourglass and more - perfect for adding that touch of luxury! Everything in my kit is tried and tested by me so I can wholeheartedly believe in them and know they work.

## **GOING ABOVE & BEYOND**

I always like to go the extra mile for my brides making sure you receive the best possible experience - whether that's delivering button holes where they should be, doing up a necklace or shoe, or delivering the rings to the best man (yes - that's happened before). I am that extra pair of hands you didn't know you needed!

# FAQS

## ARE YOU INSURED?

I am fully insured by ABT and can provide details should your venue need them.

## WHAT PRODUCTS DO YOU USE?

I use a range of premium brands in my kit and nothing makes it into my kit if it hasn't been tried and tested by me first!

## HOW LONG IN ADVANCE SHOULD I BOOK YOU?

The earlier the better! My 2028 diary is open and filling up quickly so to avoid any disappointment it's worth booking as early as you possibly can!

## HOW MANY PEOPLE CAN YOU DO IN ONE BOOKING?

This depends on a range of different factors (i.e. access time, ceremony time, how early you are willing to start etc.) I will get as many people done as I possibly can before recommending an assistant.

## HOW LONG DO YOU TAKE PER PERSON?

The absolute minimum I will allow is 45 minutes per Bridal Party member and 60 minutes for the Bride. If time allows the ideal time slot would be 60 minutes per Bridal Party member and 60-90 minutes for the bride.

## IS THERE A MINIMUM BOOKING?

Due to the nature of my business being seasonal and exceptionally busy on weekends, there is a minimum booking of **Bride + 3** on any Friday or weekend date between 1st May and 30th September. Extras add into this price, however the fees do not. This minimum booking may differ if travelling over 2 hours.

## CAN I TRIAL YOU BEFORE I BOOK FOR MY WEDDING?

Your trial is included in the price. This is because I encourage brides come for a trial before your wedding so we can meet and perfect your bridal look before the big day. We can do a trial at any time but I would recommend around 2-3 months before.

## HOW DO I BOOK MY TRIAL?

There is no need to worry. I will be in touch to book this with you, and we will be looking at around 2-3 months before your wedding.

# FAQS

## **CAN I BRING PEOPLE TO MY TRIAL?**

Please do! I would recommend bringing the Mother of the Bride or your most honest friend - it's nice to get a second opinion. My studio space only has enough room to bring one extra person, and it's not 'child-proof' so please leave little ones at home. It is also absolutely fine to come on your own too!

## **WHAT IF I MAKE CHANGES TO MY LOOK AFTER MY TRIAL?**

This is the beauty of a trial... it means you can *trial* your makeup. We will take the time to ensure you are 100% happy before you leave but I am more than happy to accommodate any changes after this time. I ask brides to send over a 'report' at the end of the day with initial changes (if any), but even if there's things that crop up nearer the time I am more than happy to work with this to achieve your dream look!

## **AM I COMMITTED TO BOOK IF I'M NOT HAPPY WITH THE TRIAL?**

If you are not happy with the trial and choose not to proceed with my services, you can cancel your booking. The cost of the trial and deposit will be deducted and anything extra paid can be refunded to you (within the cancellation period).

## **WHAT SHOULD I BE DOING TO PREPARE FOR MY TRIAL?**

I will send over all the information you need when you book your trial!

## **CAN MY BRIDAL PARTY HAVE A MAKEUP TRIAL TOO?**

Absolutely - we can do my 'special occasion makeup' service which lasts an hour and costs £65. We can do a glam from start to finish so they can see the style and see how it lasts on the skin.

## **WHY DO I NEED TO PAY A DEPOSIT?**

Due to the nature of my business and high demand I need a deposit to secure your booking. I am extremely busy, especially during the peak wedding season, and often have multiple enquiries for the same date. Without your deposit your date can be booked by someone else. All deposits are non-refundable and non-transferrable.

# TERMS & CONDITIONS

- DEPOSITS ARE NON-REFUNDABLE AND NON-TRANSFERABLE.
- TO SECURE YOUR WEDDING DATE A **£50 DEPOSIT IS REQUIRED**. YOUR DATE IS NOT CONFIRMED UNTIL THIS DEPOSIT HAS BEEN RECEIVED.
- ON THE DATE OF THE TRIAL *50% OF THE BALANCE* MUST BE PAID. THE FINAL PAYMENT IS DUE *14 DAYS PRIOR* TO THE WEDDING DATE.
- FAILURE TO MAKE PAYMENT OF THE FINAL BALANCE WILL RESULT IN YOUR BOOKING BEING CANCELLED WITH NO REFUND GIVEN.
- IF, IN THE UNLIKELY EVENT I HAVE TO CANCEL THE BOOKING, YOU WILL RECEIVE A COMPLETE REFUND OF ANY PAYMENTS MADE.
- IN THE UNLIKELY EVENT I AM UNABLE TO MAKE THE BOOKING ON THE DAY DUE TO AN EMERGENCY, I WILL TRY TO FIND ANOTHER ARTIST WHOM I TRUST. THEY WILL RECEIVE ALL THE INFORMATION I HAVE (PRODUCT LIST/FACE CHART/PHOTOS) AND ANY PRODUCTS THEY NEED TO USE FROM MY KIT.
- CANCELLATIONS MADE LESS THAN ONE MONTH PRIOR TO THE WEDDING DATE WILL NOT RECEIVE ANY REFUND. CANCELLATIONS MADE BEFORE THIS CUT OFF MAY RECEIVE A PARTIAL REFUND.
- PAYMENTS CAN ONLY BE ACCEPTED ON THE DATES GIVEN. EARLY PAYMENTS CANNOT BE ACCEPTED. PAYMENTS ON THE DAY WILL NOT BE ACCEPTED.
- IF ANY ADDITIONAL SERVICES OR CHARGES ARE REQUESTED AFTER THE INITIAL QUOTE I RESERVE THE RIGHT TO AMEND THE FINAL BALANCE. THESE MAY INCLUDE, BUT ARE NOT LIMITED TO, TRAVEL ADJUSTMENTS, CHANGE OF LOCATION, ASSISTANT FEE, OR OTHER REQUIREMENTS THAT WERE NOT DISCLOSED AT THE TIME OF BOOKING.
- IF YOU DECIDE TO CHANGE/POSTPONE YOUR WEDDING DATE A SUPPLEMENT WILL BE APPLICABLE TO BRING THE QUOTE INLINE WITH PRICE INCREASES FOR THAT YEAR.
- CHANGES TO THE BRIDAL PARTY SIZE CAN BE ACCOMMODATED UP TO FOUR MONTHS BEFORE THE WEDDING DATE. ANY CHANGES MADE AFTER THIS WILL BE CHARGED THE ORIGINAL QUOTED PRICE. BOOKING MUST STILL MEET THE MINIMUM BOOKING.

## **ON THE DAY**

- STICKING TO THE SCHEDULE IS ESSENTIAL TO ENSURE THAT ALL SERVICES CAN BE COMPLETED ON TIME AND TO THE QUALITY I PROVIDE. IF ANY OF THE BRIDAL PARTY ARE LATE I RESERVE THE RIGHT TO REDUCE SERVICES ACCORDINGLY WITHOUT REFUND.
- MY KIT IS RESERVED FOR THOSE ALREADY BOOKED IN WITH ME. MY KIT (E.G. LASHES/SETTING SPRAY/LIPSTICK) WILL NOT BE SHARED WITH THOSE OUTSIDE OF THE BOOKING.
- IT IS EXTREMELY UNLIKELY THAT I WILL BE ABLE TO ADD EXTRA SERVICES ON THE DAY. IF I AM ABLE TO, THESE WILL BE INVOICED AND MUST BE PAID WITHIN 7 DAYS OF THE WEDDING DATE.
